THE POLICY STATES THAT ISDD'S EXECUTIVE COMPENSATION/HR COMMITTEE MAKES THIS DETERMINATION BASED ON DATA WHICH DOCUMENTS COMPENSATION LEVELS AND BENEFITS FOR SIMILARLY QUALIFIED INDIVIDUALS IN COMPARABLE POSITIONS AT SIMILAR ORGANIZATIONS. THE COMMITTEE DOCUMENTS HOW IT REACHED ITS DECISIONS, INCLUDING THE DATA UPON WHICH IT RELIED, THE PERSONS WHO WERE PRESENT DURING THE DISCUSSION ABOUT COMPENSATION AND BENEFITS AND THE RESULTS OF THE VOTE, A DESCRIPTION OF THE COMPARABILITY DATA AND HOW IT WAS OBTAINED AND ANY ACTIONS TAKEN WITH RESPECT TO THE CONSIDERATION OF THE COMPENSATION BY ANYONE WHO HAD A CONFLICT OF INTEREST.
